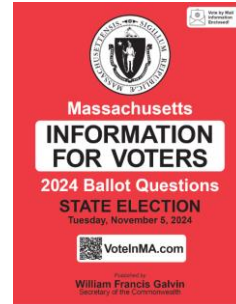
This guide outlines the multiple options voters have to participate in the Presidential election.

## REPRECINCTING

**What's My Precinct?**

Pursuant to MGL Ch. 54 §6, the Town of Easton has changed its voting precincts as a result of population changes from the 2020 Federal Census. These changes include the addition of a 7th precinct and a precinct with split representative districts – 4A & 4B.

For most voters, but not all, precinct numbers have changed. The Town has a total of 9,901 Voting Addresses, 5,329 of those addresses have precinct #'s that have changed.

## [Vote by Mail](#)

All registered voters qualify to vote by mail.

**Received a postcard application?** The Secretary of the Commonwealth is required to mail ALL voters who have not already applied for a vote by mail ballot, a postcard application – this is usually mailed out 45 days prior to state elections. This postcard application will allow you to apply for a vote by mail ballot for all elections this year or for individual election this year.

Applications can be returned by mail (postage is pre-paid on the post card application mailed to you) or placed in the silver tax collectors drop box outside of the Town Offices (136 Elm St). A signature is required in order to process your application. Questions can be directed to [votebymail@easton.ma.us](mailto:votebymail@easton.ma.us).

**APPLY EARLY** to allow ample time for processing your application and for the postal services to deliver your ballot to you. If you are concerned about applying too early - please note that voters can hold on to their ballot and return it the week prior to the election in the secure ballot drop box outside of the Town Offices. Voters who receive a vote by mail ballot and have not returned it may appear to vote in person at an early voting site or on election day to cast a ballot. Any voter that has returned a vote by mail ballot (or voted early in person) cannot vote on Election Day.

Voters who have applied for a vote by mail ballot may use this link to track the status of their application as well as their ballot status (mailed / received back). Please note that we anticipate a large volume of applications (there are over 17,000 voters in Easton) and request you **allow at least 1 week before checking the status of your application and allow a minimum of 10 days to receive your ballot from the status date of mailing**. Please DO NOT contact the Town Clerk's Office to check on your status until the recommended amount of time listed above has passed. ### **RETURN OF VOTE BY MAIL BALLOTS**

Once you receive your ballot, please vote promptly, place the ballot in the manila ballot envelope and sign the required affidavit. Place the sealed ballot envelope in the postage paid white return envelope and return by U.S. mail or place it in the secure ballot drop box at the Town Offices at 136 Elm St.

Mailed Ballots include a postage pre-paid return ballot envelope that is addressed to the Town Clerk's Office. You may return your ballot by mail (please see deadlines below) or hand deliver your ballot by placing it in the secure ballot drop box outside of the Town Offices (deadline is close of polls on Election Day).

Ballots can NOT be returned to the polling location on Election Day - they must be returned to the secure ballot drop box located at the Town Offices (136 Elm St). Your returned ballot on Election Day will be processed and brought to the polls to be cast by the Town Clerk's staff.

#### Deadlines for ballots to be returned and counted for November Election:

- Ballots returned in the secure ballot drop box must be received by **8PM on November 5<sup>th</sup>**
- Ballots returned by mail must be **postmarked by November 5<sup>th</sup>** AND received by the Town Clerk by **5PM on November 8<sup>th</sup>**

Please note that US Postal delivery services are not consistent and can range from 3 to 11 days. We recommend voters return their ballots in the secure ballot drop box outside of the Town Offices by 8PM on Election Day to ensure it is counted.

### REQUESTED A VOTE BY MAIL BALLOT – OTHER VOTING OPTIONS

Voters who receive a vote by mail ballot but have not returned it prior to Election Day may appear to vote in person and cast a ballot on Election Day. Any voter that has returned a vote by mail ballot (or voted early in person) is not permitted to appear to vote in person on Election Day.

## KNOW BEFORE YOU GO TO VOTE

Educated voters will reduce time in the voting booths, reduce lines & crowding at the voting site.

### What to Bring or Know when voting early in person:

## Electioneering During Early Voting in Person

The Select Board adopted policy #92 with the following regulation for the period designated for in-person absentee voting and the State's Early Voting Period:

No poster, card, handbill, placard, picture or circular intended to influence the action of the voter, other than those expressly authorized by G.L. c. 54, § 65, shall be posted, exhibited, circulated or distributed in the Town Clerk's office, in the building where the Town Clerk's office is located, on the walls thereof, on the premises on which the Town Offices at 136 Elm Street stand within one hundred and fifty feet (150') of the building entrance door to said Town Offices.

## **EARLY VOTING (by mail or in person) FAQ:**

**If I applied for a vote by mail ballot can I appear to vote in person at an early voting site or at the polls on Election Day?**

**YES** - If your vote by mail ballot has not been received back to the Town Clerk's Office, you may still appear to vote in person at the polls on Election Day or at an early voting site. These voters will be required to complete additional paperwork and will need to show an ID. Should your mail in ballot be received after you voted early in person or at the polls on Election Day that ballot will be rejected and will not be counted.

**NO** – If your vote by mail ballot has already been received back by the Town Clerk's Office. A returned vote by mail ballot is considered cast and you will not be eligible to vote by mail, early in person or in person at the polls on Election Day.

**If I vote early in person can I appear to vote in person at the polls on Election Day?**

**NO** - If you appeared to vote early in person your ballot will be considered cast and you will not be eligible to vote by mail or in person at the polls on Election Day. Voting in Person at the polls after submitting an early ballot is prohibited as outlined in 950 CMR 4 7.19.

**When & how is an early voter's ballot (by mail or in person) cast?**

All vote by mail and early voting in person ballots will be opened and inserted into a tabulator before election day or fed through the tabulators at the polls on Election Day. These ballots will be kept secured, locked, and unexamined until the polls are closed on Election Day.

**Notice of Advance removal and depositing of Early Voted Ballots** *(date/times may change)*

In accordance with the provisions of Chapter 54 section 25B as amended by Section 10 of Chapter 92 of the Acts of 2022, the Town of Easton may be opening and/or depositing early voted ballots at the Town Offices, 136 Elm Street for this upcoming Election. Once available, notice of dates/times can be found on the [town's website](#).

We respectfully ask that observers register in advance (before the end of the business day prior) of all processing of early voted ballots sessions by emailing [townclerksoffice@easton.ma.us](mailto:townclerksoffice@easton.ma.us).

A full record of advance removal and advance depositing will be kept for each session. In accordance with the provisions of Chapter 54 section 25B as amended by Section 10 of Chapter 92 of the Acts of 2022, no results shall be determined or announced until after the time the polls close on Election Day. At that time, the results from the advance processed ballots will be added to the election day results and posted in a public place.

All Elections are held at the Oliver Ames High School Gym - 100 Lothrop St, Easton, MA 02356

All voters must enter from the Atrium / Gym Entrance

- Precincts 1, 2, 3, 7 - vote in the New Gym
- Precincts 4A, 4B, 5, 6 - vote in the Old Gym
